

Filing period: Monday, February 16 to Monday, March 16

Submit income tax returns (final tax returns確定申告) to the Okinawa Tax Office

Required documents: Final tax return form

《Filing an income tax final return eliminates the need to file municipal/prefectural tax returns》

Submit municipal/prefectural tax returns to the Residential Tax Division, Okinawa City Hall

Required Document: Municipal/prefectural Tax Return with National Health Insurance Premium Filing Form

Please be aware that city hall does not accept the form for "income tax returns (final tax returns確定申告)" by mail.

Please use "e-Tax" for filing income tax returns (final tax returns).

Filing your final tax return electronically eliminates the need to file municipal and prefectural tax returns.

You can file using your My Number Card and smartphone via the National Tax Agency's LINE account (国税庁LINE).

Due to the ongoing situation where citizens face long wait times each year, we kindly request your cooperation in using electronic filing.
Municipal and Prefectural Tax Filing 市・県民税の申告

◎ If you are unable to file electronically, please file your municipal and prefectural tax return by mail. Those who had no income during the previous year (Reiwa 7) or who only received salary or pension income can file by mail. Please gather your withholding tax statement, pay statement, certificates required for deductions, etc. Affix postage to an envelope, include the completed municipal/prefectural tax return form, and enclose copies of the relevant certificates. Mail this to the Residential Tax Division at Okinawa City Hall (沖縄市役所市民税課).

※ If there are any errors in the information you provide or in your documents, we may need to call you to verify the details. Please be sure to include your phone number.

◎ Information on Municipal and Prefectural Tax Return Acceptance Venues

Reception Hours: February 16 (Mon) to March 16 (Mon)

※ Weekend reception available on March 15 (Sun) only

Reception Location: Entrance Lobby (1F), Okinawa City Hall

※ Parking lots and surrounding roads will be extremely congested during the filing period. Please cooperate by using public transportation.

※ For detailed information, including downloading the tax return form and sample forms, please check our official website.

※ Please note that incomplete or disorganized documents will not be accepted.

As the filing deadline approaches each year, the office becomes extremely crowded and wait times increase significantly. Please file your return early.

To avoid congestion, we have allocated specific filing dates as shown below.
