

## Tax Deduction Application for Persons with Disabilities



Individuals with a condition equivalent to those approved for a shogai-techo (physical or mental disability certificate) or ryoikutecho (psychiatric disability certificate) are also eligible to be approved for tax deductions under income tax and local tax laws.

In Okinawa City, if you are at least 65 years old and any of the following below applies to you, you can be approved to be issued 🛮 a **shogai-sha kojo taisho-sha nintei-sho** (a tax deduction certifi-

cate for persons with a disability). If you are eligible for this certificate and need it for filing your taxes, please come to the Korei Fukushi Ka (Elderly Welfare Division) service counter for assistance with the application process.

- ⇒ Only those who are approved as yo-shien (support level) or yo-kaigo (care level) based on the Long-Term Care Insurance Act are eligible for this service.
- Those who are already shogai-techo or ryoiku-techo holders can submit their disability certificate to receive tax deductions. They do not need to apply for this service.
- ⇒ Please bring your inkan when you apply.

# Filing City & Prefectural Residence Tax & National Health Insurance Premiums for Fiscal Year 2014

- When can I file my taxes? Between February 17 (Monday) ~ March 17 (Monday). Closed on Saturdays and Sundays (except March 16th [Sunday]).
- What are the hours? 9:00 am~ 4:00 pm
- Where do I file my taxes? Okinawa City Hall 1F lobby
- What is the filing schedule by district? A schedule divided by districts (see below) has been created in order to prevent overcrowding. Please come and file on the day your district is scheduled. Please file by March 17th (Monday) if you are not able to on the scheduled dates.

- \* Please remember to come to the Okinawa City Hall to file. You cannot file at any jichikai-jimusho (neighborhood council office).
- \* Parking lots will be extremely crowded during this period. We encourage you to use public transportation. There will be overcrowding as the deadline for filing approaches (usually between March 11~17), and long waiting times are to be expected. We apologize in advance to residents for this inconvenience, and encourage you to file early.
- \* A provisional local tax law has been established and there will be a 1,000 yen increase in residential tax per individual (500 yen increase per city and prefectural tax). We ask for your understanding on this matter.

# Filing Depreciable Assets for FY 2014

This applies if you own any depreciable assets used for business as of January 1, 2014 (the assessment base date), not including land or building establishments (see "Applicable Assets" list below.) (If you own even one depreciable asset, you are still subject to report and file them, whether or not you are taxed.) Please remember to indicate your line of business.

#### **Applicable Assets**

- Assets acquired or lost between January 2, 2013~ January 1, 2014
- Assets acquired before January 1, 2013 that are currently being utilized.
- Assets utilized up until now, but disposed or transferred as of January 1, 2014.

Filing Period / 2014 January 6 (Monday)~ 31 (Friday)

Where to file / Shisan Zei Ka (Property Tax Division), Kaoku Gakari (Building Establishment Section).

#### Important message from Shisan Zei Ka

#### Submit a notice in the following cases:

- Establishments you presently own have been torn down
  - messhitsu shinkoku sho (disposition of property report)
- New establishments or extensions to already existing ones have not yet been registered
  - kaoku shinkoku sho (building establishment report)
- There is a change in your establishment's intent of use
  - kaoku shinkoku sho (building establishment report)
- Establishments that were bought or sold, donated or inherited have not yet been registered
  - shoyu-sha henko gan (transfer ownership)
- The owner of the fixed asset has passed away and the inheritance process is not complete
  - sozoku daihyo-sha shitei todoke (inheritance notification)
- You live outside of Okinawa City and have difficulty making tax payments
  - -nozei kanri-nin shitei todoke (tax agent notification)



Submit a proxy letter if a representative applies to issue any documents related to your income or property.

Automatic reimbursements for subsidized children's medical expenses begin January 1, 2014. If you show your "Kodomo Iryo Joseikin Jyukyu Shikakusha Sho (Jido Shokan)" (an orange colored card which serves as proof that you qualify to receive subsidies for your child's medical expenses and automatic reimbursements) at the reception window at any medical facility within Okinawa Prefecture that support this system, your reimbursements will be automatically deposited to the bank account which you register. You no longer have to come directly to the Kodomo Katei Ka service counter to apply for your reimbursement.

#### **IMPORTANT**

- → Medical facilities outside of Okinawa Prefecture. as well as some within Okinawa do not support this system. Please show your orange certificate and confirm directly at the hospital's reception counter.
- → Reimbursement applications for medical care received up to December 31, 2013 must still be processed at Kodomo Katei Ka. (You must apply within a year from the month after you have received medical care in order to receive a reimbursement.)
- → Please apply at the Kodomo Katei Ka service counter to have the orange certificate issued so you can use this system.


#### Bring the following to apply:

- 1. The child's insurance certificate
- 2. The parent/ quardian's bank passbook
- 3. The parent/ quardian's inkan

\*If your child already has a certificate (yellow card) showing they are qualified to receive benefits and was born after January 2, 2009, the new orange colored certificate will be sent by mail. Those who will stay at a hospital after January 1. 2016 must have the new certificate issued at the Kodomo Katei Ka service counter. (The age criteria to receive subsidies with this new system are
