A New Okinawa City: Mayor Kuwae To Develop a Lively **Community for Citizens**



The inaugural ceremony for the new Mayor of Okinawa City, Sachio Kuwae, was held on May 12 in front of the Okinawa City Hall entrance. Mayor Kuwae, who won the mayoral election for the first time on April 27, received a bouquet congratulating his inauguration and walked through warm applause given by citizens and city officials.

Mayor Kuwae, inaugurated as the 11th Mayor of Okinawa City, declared that he would revitalize the city, generate employ-

ment, work on the development of a lively community for children, youth and the elderly, and create a new Okinawa City.

In his inauguration speech, Mayor Kuwae stated that citizens placed their hopes and confidence in his campaign pledge and trust that he will implement his promises. He declared his determination to faithfully carry out his pledge to develop the city and improve the welfare of citizens in order to make Okinawa City the most lively city on island that gives youth vision and hope. Mayor Kuwae further expressed that the citizens, communities and the city itself each play a leading role in creating a new Okinawa City, and to support each role he would realize projects one by one in cooperation with city officials.



► Rinji Fukushi Kyufu Kin and Kosodate Setai Rinji Tokurei Kyufu Kin

("Temporary Welfare Allowance" and "Temporary Allowance for Families with Small Children")

With the 8% increase in sales tax, Okinawa City is planning to provide temporary allowances called Rinji Fukushi Kyufu Kin (Temporary Welfare Allowance) and Kosodate Setai Rinji Tokurei Kyufu Kin (Temporary Allowance for Families with Śmall Children), starting April 2014, to reduce the financial burden of low income households and families with small children.

Note: You can only receive one of the two allowances.

Application Process ~General Flow Until You Receive The Allowance~

The application process to receive the allowance is as follows:

1 June

A form to request the application form will be sent to all households. Please confirm and return the request & consent form.

2 After June

The application form will be sent to those who fulfill all conditions. Those who did not qualify will be notified.

3 September 30 Deadline Fill out the application form and send or submit it to the city hall.

4 2 months after applying (As a result of evaluation) The allowance will be transferred into your account.

- In order to determine your tax situation, please make sure to return the request & consent form sent from the city hall in June.
- Both allowances will be provided by the municipality you were registered in on January 1, 2014.
- The application period is July 1, 2014~ September 30, 2014

► Increase Your Old-Age Pension Benefits: "Additional Pension" System

If you are a category 1 insured person or a voluntary affiliate of the pension system, you can increase the amount of benefits you will receive by paying ¥400 in addition to the fixed monthly insurance premium amount. The additional pension amount you will receive will be ¥200 x the number of months you pay the additional amount. Example: You pay the additional ¥400 for the next 10 years. The additional amount you will pay is ¥48,000 (¥400x10 Years [120 months]). When you begin to receive your elderly pension benefits, the additional amount you will receive in one year will be \(\frac{4}{24}\).000 (\(\frac{4}{200}\)x10 Years [120 months]). In other words, the additional premium you paid over a span of 10 years will come back to you in just 2 years, and you will only profit from the rest after that! **The ¥400 must be paid in addition to your monthly premium.

More announcements...

► <u>Jido Teate Genkyo Todoke</u> (<u>Present Circumstance Report for</u> Child Benefits)

If you are presently (as of June 1, 2014) receiving child benefits in Okinawa City, you must submit a *genkyo todoke* (a notification reporting your present circumstances). If you do not submit this notification, your benefits will be suspended (for payment terms after October).

- Notification forms will be sent mid-June.
- Submission dates have been scheduled as crowding during this period is expected. If you are unable to visit the Children's Welfare Division on the date scheduled for your district, you can submit the notification anytime within the submission period.
- Persons permitted to submit the notification are limited to you, your spouse, or a family member of the same household

Submission Period: June 12 (THU)~ 30 (MON) (Excluding weekends and June 23rd, a public holiday on Okinawa)

Submission Hours: 8:30~ 17:15 (including lunch hour, 12:00~ 13:00)

Location: Okinawa City Hall *Kodomo Katei Ka* (Children's Welfare Division) 2F

What to Bring:

- (1) The notification form sent to you
- (2) The *inkan* (personal seal) of the person submitting the form.
- (3) Copies of the recipient's (the bank account holder's), and each child's health insurance certificates (unnecessary for national health insurance holders)
- (4) Income certificate for Child Benefit for the FY2014 (only needed if you moved into Okinawa City after January 2nd)
- (5) A copy of your child's residence record (juminhyo-tohon) (Only required for those who are separated from, but have custody over children under 18 years old who live outside of Okinawa City.)

► Community Dental Care for the Disabled

► Proof of income for the FY 2014

Proof of income can be issued after June 2, 2014 (MON). **Who does this apply to?** Those who have been living in Okinawa City as a registered resident as of January 1, 2014 up to present and have filed their income by the deadline, or those who have become a dependant.

Who can request proof of

<u>income?</u> You or someone from the same household can request proof of income.

<u>What documents are required?</u> Documents such as your driver's license, health insurance certificate, residence card, or passport.

XA power of attorney will be required for requests submitted by those who are not of the same household.
