For Single Parents(ひとり親家庭の自立支援事業)

This program assists single parents by providing partial financial support for eligible vocational train-

ing/certificate course expenses

(for study materials).

Eligibility: Single parents who are currently living in Okinawa City and also satisfy all the requirements listed below:

- 1 You are single parent who wants to find a job with their acquired vocational skills or certificate after their training course.
- 2 You are a recipient of Child Rearing Allowance for Single Parents, or your amount of income meets the standard requirement to receive an allowance.
- 3 You have never received this benefit before.
- Eligible Training: Designated classes offered under the educational training benefit of the Employment Insurance Act (雇用保険法) and has a high potential of finding a job with the acquired skills.

(Example) Beginning operators' training for care staff/ Certified care worker practical training/Medical processor/ Care administrator/Registered vendor/Real estate dealer/Bookkeeping etc.

Your application will be examined for approval.

# Do Not Miss the Payment Due Date for National Pension Premium Payment

The monthly amount of national pension premium between April 2023 and March 2024: ¥16,520. If you have not paid by the due date, you will



receive a notice from the Japan Pension Service asking you to pay as soon as possible.

If you do not pay your insurance premiums, you will not only receive a reduced pension in the future, but you may also be unable to receive the Basic Old-Age Pension. Basic Disability Pension, or Basic Survivor's Pension. Please make sure that you have not forgotten to pay your premiums.

You can pay by: Cash with payment slip, credit card, bank transfer, electronic payment using the internet etc..



# Discounts are available for prepayment.

Discounts are available if premiums are paid in advance. Please consider it.

The following three prepayment plans are available, and the deadline for application is the end of February 2024.

- For 6 months (April September 2024)
- For 1 year (April 2024 March 2025)
- For 2 years (April 2024 March 2026) •

# National Early Warning System (J-Alert) Drill

### On February 9 (Fri) around 11:00 a.m.,

The Fire and Disaster Management Agency will conduct a J-Alert system test. The alert system will be automatically activated after the announcement is sent via satellite, which will then be broadcast through the wireless "disaster prevention speakers" set throughout Okinawa City.



This system (J-Alert) enables us to receive instant information about earthquakes, tsunamis, and other emergencies via satellite.


