► A Notice to Parents Receiving Special Disability Benefits, Benefits for Disabled Children, or Welfare Benefits

Recipients of these benefits must submit a 現況届 *Genkyo Todoke* (Current Status Notification) in order to verify their qualifications to continue receiving benefits. Please submit the notification within the specified period.

Submission Period: August 10 (Fri) ~ September 11 (Tue)

Hours: 8:30 ~ 12:00 noon; 13:00~ 17:15 (not including Saturdays, Sundays and Japanese holidays).

Location: Shogai Fukushi Ka (Disabilities Welfare Division) Okinawa City Hall 1F

What to bring: ①The notification form sent to you (have it filled out) ② Your *inkan* ③ Documents to verify benefits in 2017 if you received disability pension or pension for the bereaved (payment notifications or your bank passbook) ④ Taxation certificate (for all household members) if you were not living in Okinawa City as of January 1, 2018. *If you fail to submit the notification, your benefits may become suspended.

► A Notice Regarding Reimbursement for Those Who Received Measles Vaccination at Their Own Cost During the Epidemic

Eligibility: Children who received the vaccination between March 23, 2018 to June 30, 2018 (the age of six months until

the age before reaching one year old)

Eligible Vaccine: MR / Single Measle Vaccination Submission Period: August 31 (Fri), 2018

Required Documents:

- Application Form (Available at Kodomo Sodan Kenko Ka 2F)
- •ID (Driver's License, Resident Card, Passport, other identification with photo)
- Receipt (Showing name of vaccine, date of administration, amount of vaccination fee)
- Bank account book *Showing the same name as the applicant
- Inkan (Rubber stamp is not accepted)
- •Mother and Child Health Record Book (If there is no vaccination record in the book, please provide the record from the hospital)

► The Copayment Rate for Long-term Care Service Will Be 30% From August (For Those Who Apply to the Conditions Below)

-You must show your "介護保険負担額割合証" (Long-term Care Service Copayment Rate Certificate) to the service provider to show which rate you pay with.

- 1.Total income amount is more than ¥2.200.000
- 2.The total amount of pension annuity and other income that household members who are 65 years old and older is as follows:
- ▶¥3,400,000 and above as a single household. ▶¥4.630,000 and above as multiple household.
 - →Copayment Rate: 30%

- 1.Total income amount is more than ¥1,600,000
- 2. The total amount of pension annuity and other income that household members who are 65 years old and older is as follows:
- →¥2,800,000 and above as a single household. →¥3,460,000 and above as multiple household.
 - →Copayment Rate: 20%

Those who do not apply to the left, or is a Category 2 Insured person, non-taxed for residential tax, and those who receive public assistance:

→Copayment Rate:10%

[Notice] If you are behind in payment and become subject to the deduction of benefit amounts, you have to pay at the 30% copayment rate (if you have been paying at 30%, it will raise up to 40%) regardless of the rate written on the "Long-term Care Service Copayment Rate Certificate". Details about the deduction of benefit amount is written on the "Long-term Care Service Copayment Rate Certificate".

► National Early Warning System (J-Alert) Drill

On <u>August 29 (Wed)</u> around 11:00 a.m., the Fire and Disaster Manage-

ment Agency will conduct a J-Alert system test. The alert system will be automatically activated after the announcement is sent via satellite, which will then be broadcast through the wireless "disaster prevention speakers" set throughout Okinawa City.

This system (J-Alert) enables us to receive instant information about earthquakes, tsunamis, and other emergencies via satellite.

► FY2018 Home Renovation Construction Subsidies Accepting Applications!

20% of home renovation construction costs subsidized (up to ¥200,000).

Additional 5% (Up to ¥50,000) for Barrier-free/ energy-saving renovation.

*In order to receive the subsidy, the construction must cost ¥200,000 or more, you must apply before you start the construction, and you must be able to report the completion of construction by the end of February 2019.

► The Medical Payment Limit for People Aged 70 and Older will be Partially Revised

After August 2018, the "Income Earner on Par With Active Employees" category will be subdivided into three categories. Also, a part of the maximum (monthly) copayment for the "Income Earner on Par With Active Employees" and "Average Income Earner" will be revised. If the monthly medical expense exceeds the maximum copayment, the balance can be reimbursed as a "High-cost Medical Care Benefit" if your application is approved.

If you are Category I & II of "Income Earner on Par With Active Employees", please get a 限度額適用認定証 (Amount Limit Application Certificate) issued. If you are under Category I & II (Low Income), get a 限度額適用・標準負担額減額認定証 (Amount Limit Application/Standard Copayment Reduction Certificate) issued. Show the certificate at the hospital when

you pay, and the maximum copayment can be applied to your expense for outpatient or hospital stay.

**This applies to those who are enrolled in the Medical Care System for Aged 75 and Over for being older than 65, and also those certified as disabled.

*1...If the patient's household has already made 3 high-cost payments within the 12 months prior to the month they received medical treatment, their fourth maximum copayment amount will be reduced to the amount within the () in the table.

August is the payment deadline for the following taxes:

Residential tax (2nd term)/ Long-term care insurance premium (3rd term)/ National health insurance premium (2nd term)/ Medical care for the elderly insurance premium (2nd term). If you use automatic bank transfers, payments will be withdrawn on August 31. Make sure you have enough money in your bank account the day before.

➤ Experimental Transportation Support Project for High School Students in Single Parent Household

Under this project, you can buy a commuter pass (**OKICA**) at half the price if you show the **discount card** that is issued by Okinawa Prefecture at the bus company counter.

Discount cards will be available through the process below.

Application Opens: Jul. 18, 2018 (Wed)
Discount Available From: Oct. 1, 2018 (Mon)
Process can take about a month until certified.
Eligibility: High school student in a household with single parent allowance/medical expense subsidy certification.

Requirement: Beneficiaries must fill out two questionnaires to verify the effect of this project.

► Subsidy for the Purchase of Hearing Aid for Kids

This subsidy will cover a part of the expense of hearing aids for children who are not eligible for a disability certificate, but suffer from a mild degree of hearing disability.

Eligibility

Okinawa City citizen who satisfy all the following conditions:

Children who are under 18 years old at the time of application./Hearing levels of both ears show over 30 decibel, which makes them not eligible for a disability certificate./Their hearing loss must be diagnosed by a designated doctor and determined that a hearing aid should be effective for the acquisition of language.

- *Applicants are not eligible if any of their household members are subject to more than ¥460,000 for resident tax per income levy, or if they are eligible for another benefit
- *The subsidy is not applicable if you are eligible for other benefits under the Comprehensive Disabled Support Act.
- *The subsidy is not applicable if you have already bought the hearing aid. Please consult in advance to applying.
