*Nursery school applications must be made after the decision

*Please note that entry can be suspended depending on the facility and its capacity situation.

*If your child is currently enrolled in a licensed government approved nursery school and wishes to apply for new developmental support daycare, please consult with the daycare center and ap-

*Children who are already using the developmental support daycare service do not need to apply again.

A Notice to Single Parents Receiving Child/Special Child Rearing Allowance

児童扶養手当現況届・特別児童扶養手当・所得状況届について Single parents who receive 児童扶養手当 (Jido Fuvo Teate -

Child Rearing Allowance For Single Parent) or 特別児童扶養手 **≝** (*Tokubetsu Jido Fuyo Teate* −**Special Child Rearing Allowance**) are required to submit a 現況届(Genkyo Todoke —Current Status Notification) every year. Those receiving "Special Child Rearing Allowance" must submit a 所得状況届 (Shotoku Jyokyo Todoke — Income Status Notification).

If you fail to submit this notification, you will not be able to continue receiving Single Parent Allowance benefits for November / Special Child Rearing Allowance benefits for August and thereafter, even if you qualify.

* The notification can only be submitted by the recipient (not by a

The notification must be submitted even if payments have been suspended due to the income limit. *If you fail to submit the required notification for 2 consecutive

years, you will lose qualifications to receive benefits. Notification to the individuals will be mailed within July. Please review it carefully for the required documents, etc.

► A Notice to Parents Receiving Special Disability Benefits(特別障害者手当), Benefits for Disabled Children(障害児福祉手当), or Welfare Benefits (経過的福祉手当)

Recipients of these benefits must submit a Current Status Report (Genkyo Todoke 現況届) in order to verify their qualifications to continue receiving benefits. Please submit the documents within the specified period. Even those whose benefit payment are suspended due to the income restriction, have to submit the current status report. *If you fail to submit the notification, your benefits may be suspended.

*You may lose qualifications to continue receiving benefits if you do not submit the documents for 2 consecutive years.

*In principle, the Current Status Report for this year should be submitted by mail.

*Please use the return envelope enclosed with the notification sent in August to return the application.

*You can also submit the Current Status Report for this year by mail.

Current Status Report on Nursery School Tuition Coverage Service

If you are receiving and also wish to continue receiving nursery school tuition coverage, you need to submit the current status

-If you are certified for nursery school tuition coverage, submit required forms to your school or Hoiku Yochien Ka (Nursery/ kindergarten Division) in Okinawa City Hall.

-If you are using services at a private nursery school out side of Okinawa City, a temporary day care, sick-kids care, or only family support center, submit them at Hoiku Yochien Ka (Nursery/ kindergarten Division) in Okinawa City Hall.

*If you do not complete this process, you will no longer be eligible for this coverage. Please complete the process during the designated period above.



► Please Complete Vaccinations During Each Vaccination Period

Each of the regular vaccinations is scheduled for age groups that are most likely to suffer from the infection.



Starting with the vaccination scheduled at 2 months old is very effective in protecting infants from infections.

Going to get vaccinated is **NOT considered an unnecessary** outing.

Please make sure to protect against infection and complete the vaccinations within each vaccination period.

*Some hospitals provide a room or time frame for vaccination recipients that is separate from regular hospital patients.

*Please make sure you bring your residence card

To the medical facility.

*Vaccination types and schedules in foreign countries (including military bases) may differ Please come to the service window to confirm your child's vaccination history record.

<Vaccination Period for Spring now>

From May 8 (Mon) to August 31 (Thu)

Eligibility: Requires completion of both the first and second vaccinations, with a minimum of 3 months passed since the last vaccination, and meeting the following conditions ①~3.

①Individuals age 65 and older.

Vaccination Voucher was mailed to residences at the end of April .

Those who have been deemed eligible by their doctor due to a high risk of underlying disease and other serious illness.

If you pay the National Pension Insurance premiums in advance, you will receive a discount on \ the premiums. Discount rates vary depending on payment method



To make national pension premium payments, you can use the payment slip sent by the Japan Pension Service and pay by credit card or cash also pay automatically transfer. Please ask about the discount rate which differs by how you make an advance payment.

■ Difference between bank transfer and each month payment by cash To prevent forgetting or getting behind on your payments, we recommend you to make automatic payments using your bank account. This will allow you to make advance payments at a dis-
