Administrative Announcements

► Regarding National Pension Premium Payment

To make national pension premium payments, you can use the payment slip sent by the Japan Pension Service and pay at your nearest <u>banking facility</u>, <u>post office</u>, <u>convenience store</u> and <u>ATM</u>. You can also pay by credit card and through the internet.

To prevent forgetting or getting behind on your payments, you can also make automatic payments using your bank account. This will allow you to make advance payments at a discounted price as follows:

Discounted price for advance payments (FY 2016):

Advance payment for a month

→ ¥50 discount (in one month)

Advance payment for 6 months

→ ¥1,110 discount (in six months)

Advance payment for a year

→ ¥4,090 discount (in a year)

Advance payment for two years

→ ¥15,690 discount (in two years)

► Two Allowances: If Either Allowance is Applicable to You, Make Sure You Apply!

Application Deadline: January 16, 2017 (MON)

Rinji Fukushi Kyufu Kin (Temporary welfare Allowance)

Eligibility: Residents of Okinawa City as of January 1, 2016 and are also exempted from residential tax for the fiscal year 2016.

- *However, the exceptions are the following:
- Dependents of a residential tax payer.
- Beneficiaries of public assistance.

Amount of Allowance: <u>¥3,000</u> per person (one-time allowance)

Shogai/ Izoku Nenkin Jukyu Sha Muke Kyufu Kin (Allowance for Disability/ Bereaved Pension Beneficiaries)

Eligibility: Beneficiaries of the above allowance (*Rinji Fukushi Kyufu Kin*), and also Disability Basic Pension (Degree 1 or 2), or Basic Pension for Bereaved for the month of May.

*Those who received the "allowance for the elderly" is not eligible.

Amount of Allowance: ¥30,000 per person (one-time allowance)

-Fill out the application form and attach the necessary documents. (If you haven't filed your taxes for the fiscal year 2016, please file it before you apply.)

We cannot pay the allowance if you have not filed your taxes.

Application Deadline: January 16, 2017

- -The form was mailed to eligible people around mid-August.
- -Those who have not applied yet should have received the form again at the end of October.

Loan System for Small to Medium Scaled Businesses

If you own a small to medium scaled business enterprise within Okinawa City and have been running the operation for at least one year, loans to finance operations, equipment or change of employment are available. However, it is required that you have been recorded in Okinawa City's Basic Resident Register since January 1st of last year and have continued to be a resident since then (this requirement does not

include representatives of a business, who may reside outside of Okinawa

City). Other terms and conditions apply.

Loan Limit: General Loan- ¥20,000,000

Special Loan—¥12,500,000

Interest Rate: General Loan Annual Interest— 1.90%

Special Loan Annual Interest—1.85% (There is a separate quarantee charge.)

Loan Period: 7 years (payment deferment possible)

Payment Method: Monthly installments

Collateral and Guarantor: Collateral and a co-signer will be requested if necessary. In addition, the Okinawa Credit Guarantee Corporation also conducts guarantees of special loans.

► Accepting Applications for the FY 2016 Home **Renovation Construction Subsidy!**

20% of home renovation construction costs subsidized (up to ¥200,000). Additional 5% (Up to ¥50,000) for Barrier-free/ energy-saving renovations.

*Rooftop heat shield/ water proof & heat shield constructions are considered as energy saving renovations.

Long-term care insurance premium (7th term)/ National health insurance premium (6th term)/ Medical care for the elderly insurance premium (6th term): Payment at bank and also automatic payment due on JAN 4. If you use automatic bank transfers, make sure you have enough money in your bank account the day before.
