► COVID-19 Vaccination Updates

Doses & Target Age

①The person who has not completed 1st & 2nd dose: 12 and older: The regular vaccine will be out of stock end of this year. If you would like to take

Omicron strain compatible vaccination (BA.1), please get vaccinated 1st & 2nd by the end of this year.

For people who are age 12 years older and completed 1st & 2nd Vaccination

and 3 months past their last vaccination can receive additional Omicron strain compatible vaccination (BA.1). Vaccination type: Pfizer or Moderna. Omicron strain compatible vaccination (BA.1) can receive one time only each person.

②For infant (6months to 4 years old)

We sent you a post card to eligible family in the middle of November.

Period: By March 31st 2023

You need to get 1st vaccination no later than 13 January 2023 to complete all vaccination by 31st March 2023.

► Your National Pension Contributions are Subject to Tax Deductions as "Social Insurance Contribution"

Your national pension premiums (contributions) are subject to tax deductions as "social insurance contribution" and you may be able to reduce the amount of your taxable income for the year.

Premiums subject to tax deductions include the total amount of contributions you paid between January to December 2022. Past payments, additional payments, and payments made on behalf of your dependent family members are also subject to tax deductions.

In order for deductions to apply, you must attach proof of premium payments when you file:

The post card on the left column will be mailed to you from the Japan Pension Service during the following months:

If you made payments between JAN 1 and SEP 30 2022: post cards are sent at the beginning of November

If you made your first payment between OCT 1 and DEC 31 2022: they will be <u>sent</u> at the beginning of February 2023

▶ Registration and Rabies Shots For Your Dog

Dogs over 91 days of age are obligated by law to be registered (one time) and given an annual rabies shot. You can register your dog and receive a rabies vaccination certificate at a hospital affiliated with the Okinawa Veterinary Medical Association. Injections fees, consultation fees, consultations and times vary depending on each hospital. To avoid congestion in the hospital, please contact each hospital before your visit.

The subsidy is given per couple and the amount will be between 50,000 yen and up to 200,000 yen, and we will subsidize half of the eligible expenses shown above. However, any fractional amounts less than 1,000yen will be rounded down.

December is the payment deadline for the following taxes:

Real-estate tax (3rd term): Payment at the bank and also automatic payment due on Dec 26.

Long-term care insurance premium (7th term)/ National health insurance premium (6th term)/ Medical care for the elderly insurance premium (6th term): Payment at bank and also automatic payment due on Jan 4. If you use automatic bank transfers, make sure you have enough money in your bank account the day before.



▶ Benefits for Child-raising households

沖縄市子育て世帯給付金

With the prolonged impact of the COVID-19, benefits will be provided to child-raising households to support their daily lives based on their actual circumstances.

1. Eligibility for Beneficially:

Applicants must fall into the following categories (1) through (3) who lives in Okinawa City:

- (1) Those who have children born after April 2, 2004 at the time of 31st August in 2022.
- (2) Those who have children born between September 1st 2022 and December 31st 2022
- (3) Those household who have children born after April 2, 2004 and moved into Okinawa city between September 1st in 2022 and December 31st in 2022
- 2. Benefit Amount: 15,000 yen per child
- 3. How to Process:

Households who Applications are NOT required.

★Households who received child allowance from Okinawa City

⇒Payment will pay to child allowance received bank on 31st October.

Households who Applications are required.

Households other than ★ (civil servant etc)

We will mail application to eligible household on Last day of the month following the application (mid-November)

Application period: By 31st January 2023.

Please contact us if you are not received application. You live separate however raising your child due to your child attending outside of area in Okinawa city.

► Japanese encephalitis Vaccination

Eligibility: Children who received the vouchers.

Required documents: Bring your vouchers.

► Antibody Test And Regular Vaccination For Rubella (40's –50's Male)

The rubella antibody test at the medical facilities has been decided to be offered as an additional provision to males who haven't received MR vaccination in the past.

You cannot receive vaccination without taking antibody test.

Eligibility: Male born between April 2, 1962 and April 1, 1979

Eligible Period: Until March 31,(Fri), 2023

Location: Designated medical facilities, and Okinawa City Group Health Examination Venue (reservation required).

Cost: Free (Covered by government)

Those who have lost their free coupon for antibody test can apply for reissuance. Please contact below for more information.
