\*\*Please be aware that you may have to wait for a long time for tax filing consultation at the tax filing venue, so please come early.

Numbered admission tickets will be distributed at the Grand Square entrance on the first floor main entrance before 10:00a.m. After 10:00 a.m., they will be distributed three times at the AE-ON Hall entrance.

Registration may be closed early depending on crowded conditions.

Tickets are also available with online pre-issuance through LINE (Japanese).

Scan the code and add "National Tax Agency国税庁" as a friend. Apply for consultation and present the completed screen at the entrance.

## ► Please Note:

February is the payment deadline for the following taxes:

Real-estate tax (4<sup>th</sup> term)/ Long-term care insurance premium (9<sup>th</sup> term)/

National health insurance premium (8<sup>th</sup> term)/ Medical care for the elderly insurance premium (8<sup>th</sup> term).

If you use automatic bank transfers, payments will be withdrawn on February 28. Make sure you have enough money in your bank ac-

count the day before.

## **Temporary Special Benefit** For Households Exempt From Residential tax, etc.

住民税非課税世帯等に対する臨時特別給付金

This is a new benefit that provides 100,000 yen per household to households that are exempt from the resident tax on a per capita basis and households that have experienced a sudden depression in their finances due to the effects of COVID-19. In order to receive the benefit, the following procedures are required.

## [Eligibility]

Category 1. Households in which all members of the household are exempt from resident tax on a per capita basis for the FY 2021. -A "Confirmation of Requirements for Provision of Temporary Special Benefit for Households Exempt from Resident Tax, etc. Form(住民税非課税世帯等に対する臨時特別給付金支給要件確認書)" will be sent to eligible households registered as residents of Okinawa City as of **December 10, 2021**. Please check the contents and return <u>it with the enclosed return envelope.</u>

\*If you have a household member who moved into Okinawa City on or after January 2, 2021, you will need to apply separately.

The form will be mailed around the end of February (subject to be changed)

Category 2. Households whose income has rapidly decreased since January 2021 and whose income is equivalent to the exemption from the resident tax on a per capita basis. -Households in which the income of all household members has decreased due to the effects of COVID-19 are eligible for this program.

### Application is required to receive this benefit.

We will verify your eligibility by confirming your estimated income (withholding tax certificate, copy of tax return, etc.) for the year 2021 or any one month after January 2021.

The application documents are available around the end of February (subject to be changed) at Temporary Special Benefit Section 非課税世帯給付金担当窓口 5F, Okinawa City Hall.

More information will be updated on our website as soon as it is decided.

### NOTES:

1. Even if you meet all of the conditions on category 1 and 2, you only apply with one of those categories. **2**. If all members of the household are dependent on relatives, etc., who are in a resident taxable household, they will not be able to receive benefits. **3**. If the details of your application are incorrect, you may be asked to return the benefits. Also, if you intentionally submit a false application, you may be charged with fraud as a fraudulent receipt of benefits. **4**. If the application is not submitted by the deadline, it will be considered that the applicant for this benefit has been declined.

# ► Do Not Miss the Payment Due Date for National Pension Premium Payment

The monthly amount of national pension premium between April 2021 and March 2022: ¥16,610.

If you have not paid by the due date, you will receive a notice from the Japan Pension Service asking you to pay as soon as possible.

If you do not pay your insurance premiums, you will not only receive a reduced pension in the future, but you may also be unable to receive the Basic Old-Age Pension, Basic Disability Pension, or Basic Survivor's Pension. Please make sure that you have not forgotten to pay your premiums.

You can pay by: Cash with payment slip, credit card, bank transfer, electronic payment using the internet etc..

### Advance payments will give you discount.

Application deadline for each advanced payment plan: 6 months in advance (Apr. –Sep.2022)—-End of Feb., 2022 6 months in advance (Oct.2022-Mar.2023)—-End of Aug, 2022 A year in advance (Apr. 2022-Mar.2023)—-End of Feb., 2022 2 years in advance (Apr. 2022-Mar.2024)—-End of Feb., 2022

# Antibody Test And Regular Vaccination For Rubella

### (40's -50's Male)

The rubella antibody test at the medical facilities has been decided to be offered as an additional provision to males who haven't received MR vaccination in the past.

### \*You cannot receive vaccination without taking antibody test.

**Eligibility:** Male born between April 2, 1962 and April 1, 1979

**Eligible Period:** <u>Until March 31, 28 (Mon), 2024</u> **Location:** Designated medical facilities, and Okinawa City Group Health Examination Venue (reservation required).

Cost: Free (Covered by government)

Those who have lost their free coupon for antibody test can apply for reissuance.

# The 3rd Dose Vaccination For COVID-19 Will Start in February!

Additional COVID-19 vaccinations to re-establish the immunity created by the body and maintain the effectiveness of preventing the onset and severity of the disease will begin this month. Who is Eligible?

Those who are 18 years old or older, registered as a resident of Okinawa City, and have been vaccinated for at least 8 months after the second dose.

\*Medical personnel and residents/workers of elderly facilities can take the 3rd dose after more than 6 months from the 2nd dose, while the elderly people at 65 years old or older can take one after 7 months have passed from 2nd dose or after February 2022. COVID-19 Vaccination Schedule
