

▶ Have You Paid Your National Pension Premium? 納めて安心国民年金

The amount of National Pension Premium between April, 2024 and July, 2025 is 16,980yen.

If you have not complete the payment by due date, you will receive the reminder from Japan Pension Service(日本年金機構). If you leave the premium unpaid, the amount of the national pension annuity that you would receive in the future will be reduced, and also you might not be able to receive the other benefits such as old-age basic pension, disability basic pension, or basic pension for the bereaved.

Please make sure you have paid your pension premium.

◆How To Pay

- With payment slip
- With credit card
- With automatic bank transfer (Apply in advance)
- With smart phone apps: Aeon pay, au Pay, d-payment, Pay B, Pay-pay, LINE Pay, Rakuten Pay, etc.

◆Discount Will be Applied For Advanced Payment!

If you pay in advance for certain payment periods, you will be able to receive a discount.

Please also consider about the "Early payment system" which allows you with the end-of-month payment for the premium of each month.

Application for advanced payment through automatic bank transfer/credit card:

●Advanced Payment Categories and the period of payments covered

6 months: April – September, 2025

12 months: April, 2025 – March, 2026

24 months: April, 2025 – March, 2027

●Application Deadline: End of February, 2025

●Date of Withdrawal: End of April, 2025

▶Maru-gaku (マル学): National Health Insurance For Students Moving Out of The City For Schooling

修学のため市外へ転出する学生の国民健康保険（マル学）について
As a principle, National Health Insurance is to enroll where the person are residing in, however, there is a exceptions (National Health Insurance Law Article 116) in case the family members in the household which enrolled in the National Health Insurance in the Okinawa City will move out of the city for schooling and also receive a living allowance from their family, they are able to continue to enroll the National Health Insurance in the Okinawa City.

Required Documents:

- National Insurance Certification of Qualification/Maru-gaku Notification(国民健康保険資格証(取得・喪失)兼マル学届出書)
- Identification document: ID with face photo-1 or ID without face photo and another document such as patient's registration card etc.

Initial Procedure on Maru-gaku Qualification

Family members in the household which enrolled in the National Health Insurance in the Okinawa City who register out of the city for schooling

Document to be Attached:

Certificate of student status (在学証明書)or student ID(学生証), etc.

Maru-gaku Qualification Renewal Procedure

For those who already have Maru-gaku qualification, they need to take an annual renewal procedure during they have a status as student. They will receive the notification form to be filled out to proof their student status in March. Please make sure to submit it by the deadline.

*If they failed to submit the form by deadline, the certificate of qualification(資格確認書) might not be issued at the renewal procedure.

What happen if they are not be qualified as Maru-gaku?

If they lost their student status due to graduation or dropping out, or if they enrolled in an employment health insurance(社会保険), they are no longer qualified as Maru-gaku and have to take a designated process.

Document to be Attached:

Those who lost their student status:

-Diploma or other evidence of termination of enrollment

*This case they would also lost a status as an insurer of National Health Insurance in the Okinawa City. If they do not enroll in an employment health insurance, enroll the national health insurance at where they are residing in.

Those who enrolled in an employment health insurance:

-Certificate of acquisition of employment health insurance (社会保険取得証明書), Certificate of qualification (資格確認書), etc.

Submission of notification is available for those how has their own "My number card".

▶ FY 2025 Tax Filing for Residential Tax and National Health Insurance Premium Please Try Your Income Tax Return Through Electronic Tax Filing (e-Tax)!

令和7年度 市民税・県民税兼国民健康保険料申告

E-Tax system which eliminates the need to file your residential tax returns (市民税・県民税) is available for you to file your income tax (確定申告) online with your “My number card” and your smart phone and it. This system save your time waiting in the city hall for tax filing.

If you are not able to file with e-tax and apply the conditions below, filing residential tax (市民税・県民税) by mail is also recommended.

-You did not have any income in 2024.

-You did not have any other income but a salary or pension in 2024.

Please send filled-out tax return form, copy of required certifications, and tax withholding certificate (源泉徴収票), payment slip, documentations for tax deduction in an envelope with a stamp applied, to Residential Tax Division, Okinawa City Hall (沖縄市役所市民税課).

*Make sure you include your phone number in case we need to contact you when there is any deficiency on the required documents.
