► Tax deduction application for those with a disability

shoqaisha tech

Individuals with a condition equivalent to those approved for a 障害者手帳 (physical or mental disability certificate) or regiku techo

療育手帳 (psychiatric disability certificate) are also eligible to be approved for tax deductions under income tax and local tax laws.

In Okinawa City, if you are at least 65 years old and certified that you apply to a certain level of physical disability or dementia, you can be apshogaisha kojo taishosha ninte

proved to be issued a 障害者控除対象者認定書 (a tax deduction certificate for persons with a disability) which will allow you to receive a deduction from income at the income tax filing process. If you are eligible for this certificate and need it for filing your taxes, please come to the Korei Fukushi Ka

This applies if you own any depreciable assets used for business as of January 1, 2016 (the assessment base date), not including land or building establishments (see "Applicable Assets"). (If you own even one depreciable asset, you are still subject to report and file them, whether or not you are taxed.) Please remember to indicate your line of business. For inquiries regarding special measures for each asset, please contact the division in charge.

► New 20-year-old Citizens! You Have Reached the Age to Join the National Pension System

Anyone who lives in Japan between age 20 and 60 are obligated to join the National Pension System. Subscribers who join the system early in their life and keep paying the premium will be able to receive their pension benefit when they get old or in case they develop a disability by injury or illness or lose a wage earner from their family.

-Pension can be a big support in the future-

The pension system is managed by the national government and an ensured life-time benefit.

-It is not only for post-retirement years -

The National Pension System can support you not only when you get old but also has these benefits:

<Disability Pension>

This benefit will be provided in case the subscriber becomes disabled as a result of an accident or diseases.

<Pension for the Bereaved>

In case the subscriber becomes deceased, eligible dependents such as their child or their spouse with child will be qualified for this benefit.


