Happy New Year to All Residents of Okinawa City!

I am optimistic that you began your new year full of hope.
Last year, we had many events that allowed us to forefeel the further growth of Okinawa City's "Sports Convention City" declaration, such as holding a Victory Parade to celebrate Hiroshima Toyo Carp's winning of the Central League championship, Ryukyu Golden Kings playing in the

championship tournament in the opening year of the B League, FC Ryukyu successfully acquiring the J2 license, and furthermore, Okinawa City being chosen to host the FIBA Basketball World Cup preliminary rounds in 2023. This encourages us to move forward to develop the multipurpose arena with a seating capacity of 10,000, and we will do our best to promote the city and prefecture's wonderful qualities to the world as we work together with related organizations.

Also, the "Origami Project" (which was started to commemorate Okinawa Citizens' Peace Day) unified the hearts of each citizen through crafting a lei of origami cranes to become a bridge of hope for peace. It was measured at an overwhelming length of 9.7 km and certified as a Guinness World Record. Okinawa City sincerely supports its citizens' strong desire for peace, and will strive to be a peaceful government.

The Okinawa City Library opened as a community and family-friendly facility to provide citizens a place to study, relax, and to activate the surrounding business area. We also started outsourcing administrative services at the Residential Division at the city hall to provide faster and better services, and also to generate employment.

Our efforts to realize becoming a "city of full of energy" is starting to take shape.

As we face the year 2018, we will continue to dedicate all our efforts into highly anticipated projects starting with the opening of the Eisa Kaikan (which will be a hub to preserve and succeed our traditions) and the new Histreet Museum (which will educate us about post-war culture), and the east-coast development project (which will be the prefecture's biggest artificial beach). We have seen new accommodations and shops open in the central business area, allowing us to feel the momentum of cultivating new business opportunities.

► Tax deduction application for those with a disability

In Okinawa City, if you are at least 65 years old and certified that you apply to a certain level of physical disability or dementia, you may be approved to be issued a

障害者控除対象者認定書 (tax deduction certificate for persons with a disability), which will allow you to receive a deduction during the income tax filing process. If you are eligible for this certificate and need it for filing your taxes, Korei Fukushi Ka

※If you already have a 障害者手帳 or 療育手帳, you can submit your disability certificate to receive tax deductions. You do not need to apply for this service.

<<What to bring for the application>>

-Applicant's inkan ("mitome-in")

-ID (Driver's License, health insurance card, etc.)

If someone will be applying on your behalf, please prepare a power of attorney.

New 20-year-old Citizens! You Have Reached the Age to Join the National Pension System

Anyone who lives in Japan between age 20 and 60 have the obligation to join the National Pension System. If you join the system early in your life and continue paying the premium, you will be able to receive your pension benefit when you get old, or if you develop a disability as a result of injury or illness, or lose an income earner in your family.

-A Big Support in the Future-

The National Pension System consists of residents between age 20 and 60 as premium pavers, and managed by the national government. This is an ensured life-time benefit.

-Not Only for Post-Retirement Years -

The National Pension System supports you not only when you get old, but it also has the following benefits:

<Disability Pension Benefit>

Provided if you become disabled as a result of an accident or disease.

<Pension Benefit for the Bereaved>

Eligible dependents, such as your child or spouse, will be qualified to receive this benefit when you pass away.

► Tax Deduction Certificate for **Medical Expenses Spent on Adult Diapers**

If you are bedridden and are certified as "long-term-care-need" in Okinawa City, you can issue this tax deduction certificate for medi-

cal expenses spent on adult diapers at the city hall if this is your second year or more to apply for medical deductions.

*If this is the first time you are applying for the deduction, please consult with your doctor to receive a "Certificate of Diaper Use."

Eligibility: You have a doctor's statement of "Bedridden Level B1~C2" and "Possibility of Incontinence." (For those who are certified as "long-term-care need" for another 13 months, the doctor's statement from the previous year is acceptable).

► Issuance of Physical Disability Certificate

-This certificate is issued to those who have a disability defined under the Physically Disabled Persons Welfare Act.

-Levels of disabilities are defined from 1 to 6, depending on the type and degree of disability.

Disability Types: Vision/hearing/equilibrium/vocal or verbal/mastication/deformity/heart/kidney/respiratory organ/bladder/back passage/small bowel/immune system/liver

The physical disability certificate enables the certificate holder to receive welfare services, benefits for assistive devices, subsidies for medical expenses, deductions on designated expenses, and tax deductions.

(*) Only doctors designated under Article 15 of the Physically Disabled Persons Welfare Act can write the diagnoses and statement. The term of validity is 3 months. The form is available at the service counter at *Shogai Fukushi Ka* (Disability Welfare Division). (**) Your individual number and ID is necessary. Contact below if you haven't applied for My number card, or apply through a representative.

► Filing Depreciable Assets for the FY 2018



This applies if you own any depreciable assets used for business as

of January 1, 2018 (the assessment base date), not including land or building establishments (see "Applicable Assets"). (If you own even one depreciable asset, you are still subject to report and file them, whether or not you are taxed.) Please remember to indicate your line of business. For inquiries regarding special measures for each asset, please contact the division in charge.

Assets To File:

- -Assets acquired/ lost between 01/02/2017~ 01/01/2018
- -Assets acquired before 01/01/2017 that you currently own.
- -Assets utilized up until now, but disposed or transferred as of 01/01/2018.

Reductions for Solar Power Generators, etc.



Solar power generators, or assets acquired by small companies to improve business may be eligible for reductions if they meet the requirements. For more information about reductions (and special exceptions), please contact the division in charge or visit our website (Japanese only).

Residential Tax (4th term)/Long-term Care Insurance Premium (8th term)/National Health Insurance Premium (7rd term)/
Medical Care for the Elderly Insurance Premium (7rd term). If you use automatic bank transfers, payments will be withdrawn on January 31. Make sure you have enough money in your bank account the day before.

► FY 2017 Home Renovation Construction Subsidy!

For Barrier-free/ Energy-saving Renovations

<u>Up to ¥250,000</u> subsidy for total cost of Barrier-free/energy-saving (insulation/heat shield) renovations.

*In order to receive the subsidy, you must apply before you start the construction, and you must be able to report the completion of construction by the end of February 2018. Applications may closed when the subsidy budget is met.



住民税 申告(Jumin Zei Shinkoku)

Residential tax is used for public services such as disaster management, road maintenance, education, welfare, and etc. All residents have to file their income at their residing (as of January 1, 2018 or of the current year) city office. But if you apply to the situation below, you don't have to file your residential tax return:

-You file your income tax return.

If you need to file your residential tax return, please visit Okinawa City Hall during the following period:

2018 February 16-March 15 9:00-16:00

*Closed on weekends, Japanese holidays <u>except</u> for March 11 (Sun).

If you miss this period, you have to wait to do this until **June 11 (Mon)**

If you visit the city hall to file your residential tax return, try this Japanese to tell the administrator, or to ask at the information desk:

"Jumin Zei Shinkoku ni kimashita.

住民税申告 に きました。'

I'm here for residential tax return.

A tax return form on the right will be mailed. Even if you don't receive it, if you think you need to file please visit the city hall.
