

Administrative Announcements

Please Note:

July is the payment deadline for the following taxes:

Real Estate Tax (2nd term)/ Long-term care insurance premium (2nd term)/ National health insurance premium (1st term)/ Medical care for the elderly insurance premium (1st term). If you use automatic bank transfers, payments will be withdrawn on July 31th. Make sure you have enough money in your bank account the day before.

Regarding the insurance certificate:

The insurance certificate and deduction certificate will be renewed from **August 2017**.

(The certificates will expire on July 31, 2018.)

Renewal of Elderly Health Insurance Certificate:

Those who are not behind on any premium payments will get their new certificate mailed to their house by the end of July.

<u>Those who are behind on premium payments</u>, please come to the National Health Insurance Division service counter with your current certificate. *Please keep in mind that if you are behind on premium payments, you might only get a temporary certificate.

Renewal of Elderly Health Insurance Maximum Co-Payment Amount Certificate/ Deduction of Standard Amount of Cost Certificate: 2. Use fans and AC to keep temperatu at 28°C/ humidity rate at 70% or below. 3. Try to stay inside during the hottest

If you are a tax-exempt household, the cost of medical treatment for your visit or the meal fee during hospitalization will be deducted by showing the Deduction of Standard Amount of Cost Certificate. If you already have one, the new certificate will be mailed with your insurance certificate. If you don't have one, you have to come to the service window to apply.

The premium payment period for the fiscal year 2017 will start in July. *The payment slip will be mailed around the middle of July.

Making payments using the secure and convenient automatic payment method is recommended.

Premium Deduction Plan Revision for the FY 2017

① Income Standard Revision for the Deduction of Per Capita Basis Amount: The income standard for the 50% & 20% deduction out of the deduction of per capita basis will be revised:

Revised Standard of Total income amount of household (insured person & head of household) **50%** Deduction– Households with income below <¥330,000 +

¥270,000 × number of the insured>

20% Deduction– Households with income below <¥330,000 + **¥490,000**×number of the insured>

⁽²⁾ Deduction of Income Levy Revision: For those who cover the amount of income levy, and their total income is ¥580,000 or less, the a 20% premium deduction will apply in the FY 2017, and no deduction will apply in the FY 2018.

③ Deduction Plan Revision for Dependents Under Employees' Insurance: The premium amount of per capita basis will be deducted by 70% as a special treatment. No income levy amount imposed. Contact: *Kokumin Kenko Hoken Ka*

Get Ready to Prevent a HEAT ATTACK!

Tips to Prevent a Heat Attack 1. Drink water constantly: Your body loses water

through your skin, breath, and by excretion. Make sure you drink a cup of water every 30 minutes even if you don't feel thirsty.



* Remember that alcohol does not help because it makes your body lose water more than you take. Supply your body with minerals after you sweat.

 Use fans and AC to keep temperatures at 28°C/ humidity rate at 70% or below.
Try to stay inside during the hottest time (13:00-15:00). If you have to go out, make sure you dress cool and get rest.
Manage your body condition with: EXERCISE to get your body to sweat properly.

EATING breakfast to supply your body with water and minerals so it can control your body temperature property. **SLEEPING** enough to keep your brain function fresh to control body temperature. Drink enough water in the morning to make up for the water lost when you were asleep.

Pay attention to the elderly and kids!

The elderly contains less water and their sense of thirst may be dull, so they should constantly be given water even if they do not feel thirsty. Keep an eye on the room



temperature, and have them exercise to sweat once a day. **Kids'** body functions are not mature enough to control their own body tem-

perature. The closer to the ground, the hotter it gets, so please pay attention to smaller kids and babies in strollers. Please pay close attention to their physical condition by looking at their face and the way they sweat. Teach them to drink water and how to dress properly. Also get them used to the daily hotness.

A Notice to Single Parents Receiving Child Rearing Allowance

Single parents who receive 児童扶養手当(Jido Fuyo Teate — Child Rearing Allowance) or 特別児童扶養手当

(Tokubetsu Jido Fuyo Teate -Special Child Rearing Al-**Iowance**) are required to submit a 現況届 (Genkyo Todoke — Current Status Notification) every year. Those receiving "Special Child Rearing Allowance" must submit a 所得状況届 (Shotoku Jyokyo Todoke — Income Status Notification).

If you fail to submit this notification, you will not be able to continue receiving benefits for August and thereafter, even if you qualify.

* The notification can only be submitted by the recipient (not by a proxy).

*The notification must be submitted even if payments have been suspended due to the income limit.

*If you fail to submit the required notification for 2 consecutive years, you will lose qualifications to receive benefits.

Child Rearing Allowance - August 1 (Tue) ~ 31 (Thu) Special Child Rearing Allowance-August 10 (Thu) ~ 25 (Fri)

Hours: Weekdays AM 9:00~11:00, PM 1:00~4:00 (not including Saturdays and Sundays).

Location: Okinawa City Hall basement level 2, Main Hall *Notifications will also be accepted on August 20 (Sunday), with weekday hours.

*In order to prevent overcrowding, we will send notices to individuals with designated dates and times.

*On Tuesdays and Fridays during the submission period, Okinawa Hellowork will open a temporary job consultation service window to focus on supporting moms and dads who are looking for a job.

Install Residential Fire Alarms for Safety

This year, guite a few number of fire cases have been reported in Okinawa City. In such emergencies, the residential fire alarms can be the first sign of caution. Install residential fire alarms for you and your family's safety!

The Fire Service Act obligates all residents to install residential fire alarms. You can get them at your nearest hardware/ DIY store.

Subsidy for the Purchase of **Hearing Aid for Kids**

This subsidy will cover a part of the expense of hearing aids for children who are not eligible for a disability certificate, but suffer from a mild degree of hearing disability. Eligibility

Okinawa City citizen who satisfy all the following conditions:

Children who are under 18 years old at the time of application./ Hearing levels of both ears show over 30 and under 70 decibel, which makes them not eligible for a disability certificate./ Their hearing loss must be diagnosed by a designated doctor and determined that a hearing aid should be effective for the acquisition of language.

* Applicants are not eligible if any of their household members are subject to more than ¥460,000 for resident tax per income levy, or if they are eligible for another benefit.

* The subsidy is not applicable if you have already bought the hearing aid. Please consult in advance to the application.

FY 2017 National Pension **Premium Exemption Appli**cations Begin July 3 (Mon)

Applications will be accepted during the following period:

Exemptions for July 2017~June 2018

*The exemption is determined based on your income the previous year. You must file your income in advance of applying.

*You can consult about receiving an exemption for the past two years.

*You may have to provide documentation if you moved into Okinawa City or have lost a job.

*If someone applies on your behalf, they must provide your inkan as well as their ID. They must also provide a Power of Attorney if they are not from the same household.

Power of Attorney---You can get the form at Pension Agency Office/Residential Division counter or you can download it from the Japan Pension Service website (Form & Sample are in Japanese).

Income Tax/ Surtaxes for Reconstruction Payment Period: July 31 (Mon) Contact : Okinawa Tax Office 098-938-0031



"Rinji Fukushi Kyufu Kin" (Temporary Allowance for Economic Policy)

Eligibility: Those who have been registered in Okinawa City as of January 1, 2016 and were not taxed for residential tax for the fiscal year 2016.

*The application form will be sent by mail at the end of June to those who are potentially eligible for the allowance and have not applied yet.

*Those who were eligible for the Temporary Welfare Allowance (¥3,000) in 2016.

**Tax filing is mandatory. Please complete your income tax filing for the FY 2016 in advance to applying.

Note: Dependents of a taxed resident or those who are receiving public assistance are not eligible.

Amount of Allowance: ¥15,000 per person (one-time payment). Application Deadline: October 10, 2017 (Tue)

• The postal mail must be marked by the deadline.
