How to Complete the COVID-19 Vaccination

Vaccination coupons are now mailed sequentially for those who are 65 years old or older depending on the supply.

- You will receive the vaccination coupon by mail.
- ◆Reserve for your 1st vaccination date.
- Go to the reserved vaccination site.
- ◆Reserve for your 2nd vaccination at the site.
- Go to the reserved 2nd vaccination site on the reserved date.

*Be sure to make a reservation for vaccination in advance.

- -If you regularly go to hospital as a patient, please consult with your family doctor in advance about the vaccination.
- -Please come dressed in clothes that are easy to show your shoulders so that you can be inoculated easily.



► The automatic certificate delivery service will be shifted from the automatic delivery machine to the convenience store delivery service.

The service of issuing certificates using automatic certificate issuing machines located in two

locations in Okinawa City (in the main office of the City Hall and in the Water and Sewerage Bureau) will be discontinued as of November 30th, 2021.

To use the service, you will need a "My Number Card (with electronic certificate for user verification)".

*It takes about a month to create a my number card.

*Your current "Hibiscus Card" will be used as a "seal (Inkan) registration card" even after the service of the automatic certificate issuing machine ends.

Please do not dispose of your Hibiscus card as you will still need it to issue a seal registration certificate or change your registered seal (Inkan) at the counter.

► Proof of Income for the FY 2021 (Income in 2020)

Proof of income (for 2020) can be issued after June 1, 2021 (Tue).

Applicable to: Those who have been living in Okinawa City as a registered resident as of January 1, 2021 up to present and have filed their income by the deadline, and those who have become a dependent.

Who can request proof of income: You or someone from the same household can request proof of income.

Required documents: Your driver's license, health insurance certificate, residence card, passport or other documents to proof your identification (A Power of Attorney will be required for requests submitted by those who are not of the same household).

**If you have your "my number card" and you are not a dependent, you can get your income certificate and also income taxation certificate issued at convenience stores. Issuance at convenience stores will available after June 1(Tue) 13:00.








➤ Special Livelihood Support Benefits for Low-income Single-parent Households

Kosodate Setai Seikatsu Shien Tokubetsu Kyufu Kin 子育て世帯生活支援特別給付金

With the prolonged impact of the COVID-19, benefits will be provided to low-income child-raising households to support their daily lives based on their actual circumstances.





- (2) Those who do not receive CRASP for April 2021 because they are receiving public pension, etc. **Application required**.
- (3) Those whose household finances have suddenly changed due to the impact of the COVID-19, and whose income is at the same level as those receiving CRASP. Application required.
- *Those who are "caregivers" as defined in the Child Rearing Allowance for Single Parent Law are also eligible.

2. Benefit Amount: 50,000 yen per child

*Eligible child: Children who are between their birth and the first March 31 after the day they reach 18 years of age.

3. How to Process:

-If you apply ① (those who receive CRASP for April, 2021):

You are not required to apply. The benefit should have been paid to the bank account which is same as CRASP is paid.

-If you apply ②or ③:

You are required to apply. The application form is available at Children's Welfare Division. Fill out the form and apply at the service window or by mail by no later than February 28, 2022 with other required documents.

Current Status Report (現況届) For Child Allowance(児童手当)

If you are presently (as of June 1, 2021) receiving child allowance in Okinawa City, you must submit a *genkyo todoke* (a current status report). If you do not submit this notification, your benefits will be suspended (for payment terms after October 2021).

Submission Period: <u>June 11 (Fri)~ 30 (Wed)</u> (Closed: Saturdays and Sundays and <u>June 23</u>)

Submission Hours: 8:30~ 17:15 (including lunch hour, 12:00~13:00)

Location: Okinawa City Hall *Kodomo Katei Ka* (Children's Welfare Division) **2F**

**To prevent COVID-19 infection, each submission must be made by mail using the enclosed return envelope in the notification sent to you in the beginning of June.

XSubmission must be made by either the applicant, their spouse, or the relatives living together.

*The electronic application of the current status report is currently under preparation. For details, please check the notification.

If you have to visit the city hall to apply for certain reasons, please read through the notification of current status report and make sure you get all the required documents ready before your visit.

► Calculation of Child Rearing Allowance for Single Parent Amount for Recipients of basic disability pension, etc. Has Been Changed Since March, 2021

- ①In order to adjust the amount received, the amount deducted from the Child Rearing Allowance for Single Parent (CRASP) amount will be changed from the entire amount of the pension to the additional child portion.
- ②The amount of pension is included in the calculation of income regarding the limitation of CRASP.
- *Those who are qualified for CRASP are not required to go through the procedure. Even those who are currently not qualified, if you apply for the qualification of allowance by June 30, 2011, you can receive it from March 2021 as a transitional measure.

A State of Emergency Has Been Declared in Okinawa Prefecture

Period: May 23 (Sunday) to June 20 (Sunday), 2011

Refrain from going out and moving around unnecessarily, including during the daytime, especially after 8pm.

► FY 2021 Subsidies For Home Renovation Construction

Open for Application on Monday, June 28, 2021

Are you thinking of housing reform or brick walls removal? Okinawa City will provide subsidy for those constructions. **Housing Reform**

- -The total construction cost must be more than 200,000 yen.
- -The subsidy amount is equivalent to 20% of the total eligible construction cost, with a maximum of 200,000 yen. Depending on the conditions of eligibility, the subsidy rate may be increased by 5% to a maximum of 250,000 yen. **Brick Walls Removal Construction**
- -This refers to brick walls which in a school zone. The lower of either a fixed amount of subsidy or two-thirds of the removal construction cost (a maximum of 200,000 yen) will be subsidized.
- *Home renovation refers to work to maintain or improve the functions of a house by repairing, reconditioning, or redecorating it.

Eligible Category of Construction and Subsidy Rate

- (1)Barrier-free Construction/Energy Saving Construction-Equivalent to 20% + 5% as an increased rate (up to ¥250.000)
- (1) Barrier-free construction: Widening of isles, easing of stair slopes, improvement of bathrooms and lavatories, elimination of steps, entrance/exit doors, installation of handrails, renovation of floor materials to prevent slipping, etc.
- ②Energy saving construction: Insulation of windows, floors, ceilings, walls, and roofs.
- ③Renovation of vacant houses: Constructions to change the floor plan of an existing dwelling unit, renovation of kitchen, bathroom, lavatory or toilet, renovation of water supply, drainage, electricity or gas facilities, exterior renovation of roof or exterior walls, etc.
- (A)Renovation to improve durability, etc.: Removal or repair of delaminated concrete of main structures such as columns and beams, reinforcement of columns, beams, walls, etc., reinforcement of waterproofing of rooftop areas of living rooms,
- (5) Childcare support renovation: Renovation for accident prevention and crime prevention for children, etc.* Only for childraising households.
- ®Telework promotion renovation: Construction to install indoor telework spaces, etc.
- (2) Other Eligible Construction-20% (up to 200,000 yen)
- TRepair and renovation of houses due to aging, disasters, etc.
- **®Sewer connection construction**
- construction cost)
- (3) Brick Walls Removal Construction
- (A) Total length of block walls, etc. × 12,000 yen (without foundation) Total length of block walls, etc. × 19,000 yen (with foundation)
- (B) Removal construction costs × 2/3 (up to 200,0000 yen)
- *The lower cost of A or B will be subsidized.
- ◆This is in addition to the subsidies in (1) and (2) listed above.
- @Brick walls removal construction: Removal of block walls exceeding 1.2m in height facing a road in a school zone is eligible for this project.
- *All or part of the block wall at a height of 1.2m or less must be removed.

- NOTE -

- ①Construction that has been already completed or started is NOT eligible for the subsidy. Please make sure you apply before the construction starts.
- ②Application will close as soon as it reaches the budget limit.
- 3 It is recommended that you obtain quotes from at least two companies to fully understand the details of the construction. Please make sure that the applicant is fully satisfied with the work and contract.
- *Subsidies are available for constructions that can be reported completed by February 25, 2022 (Friday).
