COVID-19 Additional (3rd) Vaccination Will Start

Regardless of occupation or age, people who are six months past their second vaccination can receive a third vaccination. Citizens 18 years and older who are eligible will receive a vaccination ticket.

Regardless of the type of vaccine (Pfizer/ Moderna/ AstraZeneca) given for the first & second dose, the additional dose will be given either by Pfizer or Moderna.

*Moderna's vaccine is given in half doses.

Temporary Special Benefit For Households Exempt From Residential Tax, etc.

住民税非課税世帯等に対する臨時特別給付金

This is a new benefit that provides **100,000 yen per household** to households that are exempt from the resident tax on a per capita basis and households that have experienced a sudden depression in their finances due to the effects of COVID-19. In order to receive the benefit, the following procedures are required.

[Eligibility]

Category 1. Households in which all members of the household are exempt from resident tax on a per capita basis for the FY 2021. - A "Confirmation of Requirements for Provision of Temporary Special Benefit for Households Exempt from Resident Tax, etc. Form(住民税非課税世帯等に対する臨時特別給付金支給要件確

認書)" will be sent to eligible households registered as residents of Okinawa City as of December 10, 2021. Please check the contents and return it with the enclosed return envelope.

*If you have a household member who moved into Okinawa City on or after January 2, 2021, you will need to apply separately. Return the required documents by May 31, 2022

Category 2. Households whose income has rapidly decreased since January 2021 and whose income is equivalent to the exemption from the resident tax on a per capita basis. -

Households in which the income of all household members has decreased due to the effects of COVID-19 are eligible for this program.

Application is required to receive this benefit.

We will verify your eligibility by confirming your estimated income (withholding tax certificate, copy of tax return, etc.) for the year 2021 or any one month after January 2021.

Notice From The National Health Insurance Division: Your Insurance Cards Must Be Renewed In March.

New cards will be mailed to all households

Households which the insurance card is mailed:

Insurance cards for April 1, 2022 and later will be mailed to all households from early March 2022.

*Households that have not yet paid their premiums <u>as of February 17, 2022</u> will receive a short-term insurance card. The insurance card will be changed to annual one after you complete the payment.

Expiration date of insured person's card for those turning 70 years old: For those who will turn 70 years old between April 2, 2022 and March 1, 2023,

their insurance card will be valid until the last day of their birth-day month (or the day before if they were born on the first day of the month).

*A new insurance card (valid until March 31, 2023) will be mailed to you again before the expiration date.

Expiration date of the insured person's card for those turning 75 years old

The expiration date of the insured person's card for those who will enter the latter half of the senior citizen medical care system between April 2, 2022 and March 1, 2023 is the day before their 75th birthday.

Have You Applied For The Medical Expense Subsidy For People (Children) With Severe Mental And Physical Disabilities?

Those who hold a certificate of physical disability or intellectual disability and the following conditions apply are eligible to receive subsidies for medical expenses which accrued after they had their disability certified. (Available between a month after and within a year of payment).

► Special Payment System For Students Application (National Pension) Will Start on April 1st, 2022 学生納付特例申請

If you are 20 years old or older, even if you are a student, you are obligated to pay the National Pension Insurance premiums. However, if your income for the previous year is below the standard, you can defer the payment of the premiums under the "Special Payment System For Students".

If you are unable to pay the premiums, do not leave it unpaid, but apply for the "Special Payment System For Students". Benefits of the Special Payment System for Students:

-The period for which you have applied for the "Special Payment System For Students" is counted as the period required to receive the Basic Old-Age Pension (eligibility period).

-If you become disabled due to illness or injury, you can receive a disability basic pension.

Eligibility: Students, etc. enrolled in university, graduate school, junior college, high school, technical college, special support school, special training school, and other various schools (courses with a duration of one year or more) as defined in the School Education Law.

Required Documents: ①Applicant's ID ②Copy of student ID or certificate, etc. to prove that they are attending school. Certificates have to be issued April 1, 2022 or later. *Make sure the student ID is valid.

If a proxy applies on behalf of the student: 2 which is isted above, ID (a power of attorney will be required if the proxy is not from the same household). You can apply retroactively up to 25 months prior to the time of application.

FY2021 Okinawa City Additional Meal Support Benefit for Supplemental Meals (Private Kindergartens) If you satisfy any of the requirements for eligibility, submit the application form before the closing date.

Eligibility: A child who is receiving nursery school tuition benefit and also satisfy either 1 or 2 given below: The household with the amount of per income levy of resident tax in FY 2021 shows under 77,101 yen

(An annual income of the household is under 3,600,000 yen).

2)If you have a child that hasn't finished third grade yet and you count them as your first child, then your third child and later are eligible .

Coverage of the Benefit: Supplemental meal fees out of the school lunch fees you paid to the kindergarten from April, 2021 through March, 2022 will be covered.

Benefit Amount: Up to 4,500 yen per child

(Exceptions: staple foods (like bread or rice) and foods provided during extended child care hours.)

Required Documents: ①Application Form (available at each Kindergarten) ②Copy of receipt or certificate for the lunch fees (issued by kindergarten) ③Bank account book or cash card under the name of lunch fee payer ④Inkan (persona seal) ⑤Income & Taxation Certificate in FY2021 or W-2 2020 (only if you were living out side Okinawa City as of January 1, 2021 or are SOFA status holders) (BDocuments to prove single-parent household, such as Koseki Tohon or Child Rearing Allowance Certificate (*If applicable).

► FY 2022 Application For Nursery School Tuition Coverage Service

If you are currently using or plan to use the following facility and wish to receiving nursery school tuition coverage, you need to submit the required documents as indicated below.

Eligible Facilities: Private nursery schools which are not eligible for nursery benefit, non-approved nursery schools, temporary day care, sick-kids care, or family support center.

Application Period:

-Those who wish to receive the coverage after April, 2022 have to apply by no later than March 25, 2022.

-Those who wish to receive the coverage after May, 2022 have to apply a month prier to the month being covered.

*If you have already applied and are within the certified period, you do not need to apply.

FY2022 Okinawa City Schools Lunch Fee Aid

In order to support parents with multiple children, Okinawa City provides financial support for school lunch fees. This aid is provided to the third child and every child born after. You must apply for this service every year.



Please make sure you don't forget to apply.

Eligible Children: Children in the family who are the third child or younger out of siblings who go to elementary and junior high school.

Requirements to receive aid: Children must be Okinawa City residents. They must not be receiving public assistance or meet the standards to receive public assistance.

Application period:

March 1, 2022 (Tue) - Feb 10, 2023 (Fri)
