# The "Pensioner Support Benefits System" Will Start On October 1, 2019

If you are living off a pension, additional financial support ("Pensioner Support Benefits") will be given if you earns less than a certain amount. You have to apply to receive this benefit. You are eligible if:

and also satisfy the following:

-you are age 65 or above.

-All your household members are non-taxed for resident tax.

-Your total annual income including pension and other income does not exceed ¥879,300.

or "Basic Pension for the Bereaved":

Your income the previous year does not exceed ¥4,621,000. (This amount may be changed depending on if you have dependent family members or not.)

#### How To Apply

 $\Diamond$ If you started receiving pension before April 1, 2019: The Japan Pension Service (JPS) will send an announcement in the beginning of September to eligible people on how to apply. Fill out the enclosed postcard and submit it to JPS.

 $\bigcirc$ If you started receiving pension after April 2, 2019: Visit the Pension Office or Pension Section in Okinawa City Hall to apply for both pension and additional benefit. \*NOTE: Beware of suspicious phone calls. The JPS or Health, Labour and Welfare Ministry will never ask for your bank account information.

# Announcement For Non-taxed Households With Children Who Go To a Private Nursery School



# ①Requirements for Private Nursery School Subsidy

1. Your child goes to a private nursery school and you are also certified that you have applied to a public or governmentapproved nursery school (Document issued when you apply to public or government-approved nursery school.) 2. You are non-taxable household 3. You are not behind on payment for government approved nursery school. 4. You have paid the tuition for the month that is eligible for the subsidy to the private nursery school. 5. You are not receiving "A Subsidy on Private Nursery School Tuition for Single Parents in Okinawa City" \* You will not be eligible for this subsidy when you are accepted to a government-approved nursery school.

## 2 Requirements For Multiple Children In Private Nursery School Amount of Subsidy: The difference between the **Subsidy**

**1.** You are the parent of multiple children who go to a private nursery school and you are also certified that you have applied to a public or government-approved nursery school (Document issued when you apply to public or government-approved nursery school.) 2. This subsidy is provided for the 3rd and younger children. 3. You are nontaxable household **4**. You are not behind on payment for government approved nursery school. 5. You have paid the tuition for the month that is eligible for the subsidy to the private nursery school. 6. You are not receiving "A Subsidy on Private Nursery School Tuition for Single | Application Period: For subsidies from April 2019 Parents in Okinawa City" \* You will not be eligible for this subsidy when you are accepted to a government-approved nursery school.

-You are <u>not</u> receiving benefits for medical expenses (designated intractable diseases).
