► COVID-19 Vaccination Updates

Takeda's vaccine (Novavax) lowered the target age for vaccination.

On July 22, 2022, the target age for the first (1st and 2nd) vaccination was lowered to "12 years and older". *Ages 12-15 must be accompanied by a parent or guardian.

▶ Please note:

September is the payment deadline for the following taxes:

Long-term care insurance premium (4th term)/ National health insurance premium (3rd term)/ Medical care for the elderly insurance premium (3rd term).

If you use automatic bank transfers, payments will be withdrawn on <u>September 30.</u> Make sure you have enough money in your bank account the day before.

▶ The Exemption of Pension Premiums Before and After Childbirth

This exemption system has started in April 2019. The exemption period will be recorded as "paid" and will be reflected on your old-age basic pension amount.

For the exempted period you apply under this system, the amount of benefits received will be reflected as you pay the full amount of pension premium, therefore, even if you have already been approved for exemption from or deferment of National Pension Insurance premiums or special exception for student payment for the period, it will help you to apply to this exemption system.

Eligibility: Category1 insured person of the pension system, and their delivery date was on February 1, 2019 or later. *Delivery is defined as a birth that happens after 85 days (or more than 4 months) of pregnancy (includes stillbirth/miscarriage/early delivery cases).

Exemption Period: 4 months from the month preceding the month in which the expected date of childbirth or the date of childbirth falls./ In the case of multiple pregnancies, 3 to 6 months before the expected date of delivery or the month in which the date of delivery falls.

Notification Period: At the earliest, 6 months before the delivery due date. You can also submit it after the delivery. **Required Documents:** Mother and Child Health Record Book or certification issued by the hospital and mother's ID with face photo.

XID with face photo and *Inkan* of the proxy will be required when submitted by a proxy.

XA Power of Attorney will be required if the proxy is not of the same household.

► Cervical Cancer Screening From Age 20

Let's use the Cancer Examination Coupon (がん検診受診券) to receive a medical examination.

Cervical cancer is a cancer that is on the rise among women in their 20s and 30s. In the early stages, there are few symptoms, but by the time they are noticed, the disease may have progressed to the point where the uterus must be removed.

However, if cancer is detected early in cancer screening, it can be treated with a simple surgery and the uterus does not have to be removed and pregnancy and childbirth are possible in many cases.

"Cervical Cancer Screening" can detect cancer in its very early stages and "precancerous lesions" before they become cancer

Okinawa City issues a "Cervical Cancer Examination Coupon" once every two years to women over 20 years old.

► Pneumococcal Vaccination For The Elderly

- 1. Those who have never received a pneumococcal vaccine (23-Valent) and who meet the following age criteria in FY 2022.
- 2. Those who are between 60 and 64 years old with heart, kidney, respiratory function or HIV related immunity disorder (equivalent to physical disability level 1) and never received the pneumococcal vaccine (23 -Valent) are also eligible to this vaccination.

Vaccination Period: <u>Until March 31, 2023</u>

Please make sure you bring your resident card. Vaccination Fee: Covered by government.

This is a **one time** vaccination.

Where you can get vaccinated: Any designated medical facility. (Please contact for the detailed information.)

<u>**Please note!</u> *If you receive this **pneumococcal** vaccine (23-Valent) in other than the applicable year on the list, or you receive one at the other hospitals than those designated, you will not be eligible to receive it at the subsidized rate. *Please contact us if you have lost the pre-checkup sheet that should have been mailed in April to those reach the age of 65, or if you are other age than 65 and need the pre-checkup sheet.

*When receiving the new coronavirus vaccine, please pay attention to the vaccination interval. Please contact us for details.

► For The Insured of Medical Care System For The Elderly

Switching of "Reduction Certificate (減額証)" and "Limit Certificate (限度証)"

In August 2022, the "Reduction Certificate 減額証" and the "Limit Certificate 限度証" were switched (Expiration date: July 31, 2023). You can limit your out-of-pocket expenses to the maximum amount of your payment by presenting the certificate at the counter of the medical institution. To obtain the certificate, you have to apply at the city

*If there is a member of the household whose income is unknown (undeclared income, etc.), we may not be able to issue the certificate. Please apply for it after filing a tax return at the Citizen's Tax Division.

<For those who are eligible for "Reduction Certificate</p> (Category II)" Long-term hospitalization>

Upon application, meal fee will be further reduced (50 yen reduction per meal).

Eligibility: Those who have been hospitalized for more than 90 days within the past 12 months. However, the period for which the "Reduction Certificate (Category II)" is applicable.

What to Bring: A document issued by the medical institution confirming the number of days of hospitalization (receipts, etc.), insurance card.

*If a proxy is applying on behalf of the applicant, the proxy's ID (driver's license, etc.) is also required.

Percentage of window charges will change

The "percentage of medical expenses to be paid over the counter" for those with *income above a certain level will be changed.

From October 1, 2022, in order to curb the increase in medical costs and the burden of insurance premiums on the working-age population, the government has introduced a new insurance system for those with incomes above a certain level, the percentage of window charge will be **20%**.

with incomes above a certain level: Taxable income of ¥280,000 or more and the total income of pension income plus other income" is at least ¥2,000,000.

*If there are two or more insured persons, the amount must be at least ¥3.2 million.

However, for those who have to pay 20% of the total cost at the counter, there are measures to reduce the amount of burden per month.

Example: If the monthly outpatient medical expenses are 50,000 yen

*The reimbursement will be transferred at a later date to the account pre-registered as a high-cost medical care expense transfer account.

*The Okinawa Prefecture Wide-Area Healthcare Union for the Late-Stage Senior Citizens will send an application form for registration to all those who do not have an account registered for high-cost medical care remittance around mid-September.

*When you receive the application form, please follow the instructions enclosed to register your account.

Second Changeover of "Elderly Health Insurance Certificate"

The second changeover will take place in October. The new insured card (Pink) will be mailed in September by registered mail. Those who have not paid their premiums will be switched over at the counter. Please bring your current insured person's card. Current certificate (Green) will be valid until September 30, 2022. The new certificate (Pink) will be valid until July 31, 2023
